The first direct freight rail connection with France comes into operation at the Port of Barcelona



A new direct freight rail service connects the Port of Barcelona with the French cities of Toulouse and Lyon as of today. The container service, created by the companies APM Terminals Railways Spain, Synergy and Naviland Cargo, located at the BEST railway terminal, will provide four weekly connections between the Port of Barcelona and these southern French cities four times a week; three to Toulouse and one to Lyon.

The new connection is truly direct, since it will be the first rail service from Spain to France that will not have to transship or change locomotives after crossing the Perthus tunnel. This historic milestone was made possible thanks to the unique situation of the Port of Barcelona - the only port in Spain with a European UIC gauge connection from the terminal to the border with France. The service will be operated by Captrain's Stadler Euro6000 locomotives, typeapproved to operate in both countries.

In January 2024, the EU's Emissions Trading System (EU ETS) will be extended to cover CO2 emissions from all large ships (of 5 000 gross tonnage and above) entering EU ports, regardless of the flag they fly. The system covers: 50% of emissions from voyages starting or ending outside of the EU (allowing the third country to decide on appropriate action for the remaining share of emissions); and 100% of emissions that occur between two EU ports and when ships are within EU ports. The EU ETS covers CO2 (carbon dioxide), CH4 (methane) and N20 (nitrous oxide) emissions, but the two latter only as from 2026. In practice, shipping companies have to purchase and surrender (use) EU ETS emission allowances for each tonne of reported CO2 (or CO2 equivalent) emissions in the scope of the EU ETS system.

In a letter to the Commission the Transport Ministers of Cyprus, Croatia, Greece, Italy, Malta, Portugal and Spain are stressing the

carbon leakage and socio-economic risks linked to the implementation of the current EU-ETS maritime legislation entry into force on 1 January 2024. The Commission has been approached to avoid the risk of carbon and business leakage as a consequence of the current scope of the directive and it is asked to "stop the clock". Its response is uncertain yet.

UNDERSEA FOREST OF THE PORT OF CARTAGENA: The Blue Lung of the Mediterranean



UNDERWATER FOREST OF THE PORT OF CARTAGENA: the blue lung of the Mediterranean is a pioneering project promoted by the in port waters, which has managed to successfully reintroduce new specimens in the southeast of the Iberian Peninsula. Posidonia oceanica is a plant of great environmental and social value, and its recovery would bring significant benefits to both the ecosystems and the society that lives in coastal areas.

The impetus for the project originates from the Sustainability Department of the Cartagena Port Authority. The Polytechnic University of Cartagena developed the underwater robotics work to obtain the bionic cartography of the area, after which the reforestation plan was designed.

This is an assisted regeneration project, aimed in helping the repair of the ecosystem by reinforcing the recovery processes that occur naturally. For this project, the Port Authority of Cartagena relies on Laboratorios Munuera, which has successfully obtained in previous reforestation experiences with Posidonia oceanica.

After one year of project development, the figures are very positive and encouraging: the overall survival rate is 77%. The success achieved in the survival of the replanting raises the hope of this type of recovery projects for such an important habitat. The methodology developed in this case has proven to have more applications in environmental restoration projects in degraded areas.

A healthy and well-maintained Posidonia oceanica meadow off the coast is the best guarantee to ensure effective protection of the beaches and the marine coastline. In addition to the benefits derived from CO2 capture and carbon retention, Posidonia is a support for hosting a wide biodiversity, which also favors the regeneration of species dedicated to fishing. The richness of the Posidonia meadows is incomparable.

Due to the success rate in the planting, another 100 fragments of Posidonia were planted in May 2023, with plans to expand the area, through an initial action planned for four years and which will be developed on about two hectares within the port of Cartagena. We want to be able to create the largest underwater port forest.

Civitavecchia records 3M passengers, a first for an Italian port




This record is a first for any Italian port and propels Lazio into Italy's leading cruise region. Roma Cruise Terminal handled 3,014,491 transit and turnaround cruise passengers in first 10 months of 2023, and to meet demand a new cruise terminal is planned.

Civitavecchia is also an important hub for the supply of cruise ships. Around 60,000 tons of supplies are expected to be handled this year.

Pino Musolino, the president of the Port System of the Central Thyrean Sea (the port authority), spoke about the results so far,: "It's an historical achievement and the result of a concerted efforts and strategy put in place by the Port Authority together with the Cruise Terminal and the major stakeholders."

2023 is expected to close with 3.3m passengers handled. Bookings for 2024 and 2025 are also very solid and reaffirm this year's results. In response to the increase in volumes and in order to continue to improve the service provided to cruise lines, Roma Cruise Terminal will start the construction of the new Donato Bramante Cruise Terminal in the first quarter of 2024.
